Your right to withdraw consent	Where you have given consent, you have the right to withdraw that consent at any time. If you do, it will not affect the lawfulness of any processing for which we had consent prior to it being withdrawn.
Location of your personal data	We will normally keep your personal data within the United Kingdom or the European Economic Area.
How long we will keep your personal data for	We will normally keep personal data for you in line with the terms and conditions of your award contract. After this time period we will anonymise the personal information and keep it for analysis of engagement trends.
Your rights in respect of your personal data	You have the right of access to your personal data and, in some cases, to require us to restrict, erase or rectify it or to object to our processing it, and the right of data portability.
